Dear California Congressional Delegation Member:

The California State Association of Counties (CSAC) and the County Welfare Directors Association of California (CWDA) request that you cosponsor the bipartisan "Protecting the Medicaid Safety Net Act of 2008" (H.R. 5613). The measure would place a one-year moratorium on seven administration-imposed Medicaid regulations that would shift costs to states and counties and reduce benefits to many Medicaid recipients. According to the Congressional Budget Office (CBO), the federal government would reduce its funding of this federal, state and local partnership by nearly \$20 billion over the next five years.

The regulations proposed by the U.S. Department of Health and Human Services (HHS) reverse long-standing Medicaid policies and eliminate federal payments for a variety of critical Medicaid functions. The vast majority of these proposals are not responding to new federal law changes. Rather, HHS is HHS proposed them as legislation.

California recently estimated that the combined impact of the regulations would shift over \$2.1 billion in costs to the State and its counties the first year alone, and would shift over \$10.7 billion over five years. This shift would occur at the same time as the State is grappling with a \$14 billion to \$16 billion shortfall.

The rules affect payments to public hospitals; graduate medical education; rehabilitation services provided to individuals with disabilities; Medicaid outreach and enrollment in schools; coverage of hospital clinic services; case management services allowing persons with disabilities to remain in the community; state provider tax laws; and state appeals filed through HHS. Congress has already enacted temporary moratoria on some of these regulations. All those moratoria expire before July 2008. The bill would give Congress until April 1 of next year to evaluate the effects of the regulations and to craft appropriate legislative responses if necessary.

All 50 governors support this effort. CSAC and CWDA urge you to cosponsor the legislation.
