Southern California (HASC)

- Purpose of the partnership: Provide hospitals with quick and easy access to obtain Client Index Number (CIN), or Medi-Cal case denial status and reason for denial via the CIN Hotline.
- Focus of the Partnership:
 - Determine potential eligibility for hospital Charity Care program when patient doesn't qualify for Medi-Cal.
 - Assist hospitals in Securing Medi-Cal reimbursement more quickly
- CIN Hotline hours of operation: Monday to Friday, from 8:00 AM to 5:00 PM
- Partnership with: 32 HASC participating hospitals in Los Angeles County.

Multi Agency Grant (Young Men of Color)

- Purpose of the Meeting: Discuss the enrollment activities taken on by each agency to outreach and enroll the target populations.
 - DPSS was awarded \$500,000 to outreach and enroll Young Men of Color (YMOC) in to Medi-Cal.
 - YMOC are individuals between the ages of 19-32.
 - Minimum target outreach number is 15,312 YMOC.
 - Minimum target enrollment number is 2,233.
 - Medi-Cal Outreach will be doing the outreach and enrollment.
 - The grant award is for a two-year period, beginning July 1, 2014 through June 30, 2016.
- Focus of the Meeting: Share agency progress on the work plan approved by DHCS, ensure compliance regarding reporting responsibilities, and to follow-up on commitments.
- Frequency: Conference call twice monthly
