### About CDSS Housing & Homelessness Division

- The State has invested significant funding over fiscal years
   2021-22 and 2022-23 to address homelessness
- Just over **\$2 billion** of these funds were invested in CDSS/HHD programs over fiscal years 2021-22 and 2022-23.
- CDSS's Housing and Homelessness Division (HHD) programs function at the intersection of housing and social services, serving about 100,000 individuals and families annually with critical housing related supports and services.






# **CalWORKs Housing Support Program** GOAL FUNDING

To foster housing stability for families experiencing or at risk of homelessness in the CalWORKs program.

55 Counties are operating CalWORKs HSP Programs.

# **Bringing Families Home** GOAL

To increase family reunification and prevent foster care placement among participants in cases where housing instability prevents reunification or could lead to foster care placement.

51 Counties & one Tribe are operating Bringing Family Home Programs.

### GOAL

To provide housing support to seniors and adults with disabilities who are experiencing or at risk of homelessness and are served by, or in the intake process for, Adult Protective Services (APS).

### All County Welfare Director's Letter (ACWDL) dated September 21, 2022

•The Notice of Fiscal Year 2022-23 Funding letter announces \$645M in funding available across four HHD programs including for the CalWORKs Housing Support Program (HSP), Bringing Families Home (BFH) Program, Housing and Disability Advocacy Program (HDAP), and the Home Safe Program.

•Counties and continuing Tribes may submit requests for funds through **November 2, 2022.**




#### Over 3 in 4 Californians Experiencing Homelessness Are Adults Not With Children







For these community members, access to federal benefits is key to increasing income. Individuals with disabilities who are experiencing homelessness

Low-income seniors in lowincome households

Youth with disabilities aging out of foster care

Low-income parents who have a serious disability

Low-income adults with disabilities who are living alone

Individuals with disabilities are disproportionally likely to experience homelessness

"People with disabilities are disproportionately likely to experience homelessness. Point-in-time counts (i.e., counts of the people in a community experiencing homelessness on a single night) suggest that nearly <u>one quarter</u> of individuals experiencing homelessness have a disability, <u>including physical</u>, intellectual, and developmental disabilities, as well as mental health and/or substance abuse disorders." Individuals experiencing homelessness in California are increasingly older adults

"Roughly 45% of unhoused Californians in adult-only households who came in contact with the homelessness response system in the 2020-21 fiscal year were aged 50 and older."

# SSI has historically had low participation rates

### Only 50-60% of older individuals eligible for SSI are receiving benefits.


SSI awards decreased significantly during the COVID-19 pandemic

SSI new awards of benefits dropped 30% in the 1<sup>st</sup> year of the pandemic.

A disability-based application for SSI is more than 50 pages of forms.



National Average Initial Application Approval Rate (Disability Applications)



# Social Security Hearings

- ½ of SSI/SSDI applicants who attend their hearing will be approved by the Judge
- Clients are more likely to be approved when represented by an attorney
- HDAP programs can sub-contract appeals representation to legal aid.

# **HDAP Successes**

Since HDAP's inception in FY 2017-18 through December 2021:



Over 4,900 people enrolled in HDAP



Over 2,400 people permanently housed



Over 5,500 disability applications submitted




Over 1,600 disability applications approved

# Of total HDAP applications disposed, HDAP has an approval rate of 78%.

# CHANGE WELLPROJECT

Placer County

Quick Stats

Population (2020): 404,739

Point-in-Time Count (2022)

- 750 individuals experiencing homelessness
- 54% unsheltered, 46% sheltered
- 34% chronically homeless

### HDAP Program Model: Snapshot

Placer County has an HDAP team that provides both:

- Housing case management and direct financial assistance
- Disability Benefits Advocacy

HDAP team is embedded in their Adult System of Care (which also includes behavioral health services).

Sub-contract with Legal Services of Northern CA (LSNC) to represent HDAP clients at hearing level.

# CHANGE WELLPROJECT

### Placer County HDAP Program Successes:

#### Disability Benefits Advocacy

- 63% approval for SSI/SSDI initial applications
- 80% approval rate at hearing

# Collaboration is part of their culture

- Examples of collaboration:
- Granite Wellness Center (substance use treatment)
- Nonprofits such as VOA (housing)
- Shelter providers
- Housing Authority for vouchers

### They are deeply connected to community

- Receive referrals for HDAP from many sources: hospitals, shelters, other County depts. People know them.
- Work with any entity they can to ensure HDAP participants can access needed services

#### Housing

Out of 78 HDAP clients who were homeless or in temporary shelter, 48 are now in permanent housing.

# They leverage county systems

- Leverage positioning in
   County to connect HDAP
   clients to health/behavioral
   health care system
- Were able to add their funding for hearing representation to an existing County contract with legal aid

### FREED

### FREED Center for Independent Living

#### **Quick Facts**

Founded in 1985 and was one of California's first rural independent living centers.

Is a disability and aging resource center providing services to residents of a five-county area: Nevada, Sierra, Yuba, Sutter and Colusa Counties.

Formed by people with disabilities & are consumer-controlled (majority of Board and Staff have disabilities).

### **HDAP Contracted Partner: Snapshot**

Contracted by two county HDAP Programs.

#### Nevada County HDAP subcontracts both:

- Housing case management (HDAP)
- Disability Benefits Advocacy

#### Yuba County HDAP subcontracts:

• Disability Benefits Advocacy

Provide other community services such as:

- Independent Living Services
- Assistive Technology
- Transition home services from hospitals and nursing homes

### FREED as an HDAP Contracted Partner Works Because:

The moment someone walks in the door to FREED, they are working to connect that individual to all needed services. HDAP participants benefit from this broad-scope assistance.

# Trusted by the community

- Founded and led by individuals with disabilities. Deep roots in disability advocacy.
- "Everyone knows FREED." Identify HDAP participants through existing reach in the community.

### Disability Benefits Advocacy Experience

- Have been doing disability benefits advocacy since before HDAP existed.
- Have built relationships with SSA and DDS and are trusted by them.
- Person-centered model of assistance.

# Leverage their services & community connections

- Connect HDAP participants to the many services they provide, such as transportation.
- Leverage community relationships to access housing and services like ID replacement.
- Have built relationships with CoCs.
