This bill would, in addition, prohibit the University of California and California State University campuses from charging mandatory systemwide tuition or fees to current or former foster youth, who meet certain requirements, for a total of the equivalent of attendance in a 4-year undergraduate program.

The bill would also require public and private placing agencies to provide existing foster care providers with the information regarding the resource family approval program as as specified, including the revised deadline, by July 1, 2019.

This bill would revise the Medi-Cal definition of "medically necessary" for purposes of an individual under 21 years of age to federal standards related to EPSDT services. The bill would require the department and its contractors to update any model evidence of specified materials to ensure the medical necessity standard for coverage for individuals under 21 years of age is accurately reflected in all materials.

Summary: Current law provides for various public social services programs for purposes of providing on behalf of the general public, and within the limits of public resources, reasonable support and maintenance for needy and dependent families and persons, including, among others, the California Work Opportunity and Responsibility to Kids (CalWORKs) program, under which each county provides cash assistance and other benefits to qualified low-income families and individuals, CalFresh, under which supplemental nutrition assistance benefits allocated to the state by the federal government are distributed to eligible individuals by each county, and the Cash Assistance Program for Aged, Blind, and Disabled Legal Immigrants (CAPI), which provides cash benefits to aged, blind, and disabled legal immigrants who meet specified criteria. This bill would authorize, if it is within its capacity, a county to communicate with applicants for, or recipients of, benefits under those programs via computer-generated text message.

<u>AB 2030</u> (<u>Limón</u> D) CalWORKs: accommodations.

<u>AB 2370</u> (<u>Holden</u> D) Lead exposure: child day care facilities: family day care homes.

The act provides, as an exception to the above provision relating to receiving services for 12 months, that a family that establishes initial eligibility or ongoing eligibility on the basis of seeking employment shall receive services for not less than 6 months. This bill would delete the 6-month exception for families establishing initial eligibility or ongoing eligibility on the basis of seeking employment.

<u>AB 2698</u> (<u>Rubio</u> D) California state preschool programs: general child care and development programs: mental health consultation services: adjustment factors.

<u>AB 3043</u> (<u>Berman</u> D) Pupil nutrition: breakfast and lunch programs.

bill, with respect to the compensation of those key exempt management positions, would include the director of enterprise risk management and compliance and the risk manager among those positions, and would delete obsolete references.

<u>SB 998</u> (<u>Dodd</u> D) Discontinuation of residential water service: urban and community water systems.
