

### CA has the 2<sup>nd</sup> highest required "housing wage" in the nation

#### 2019 TWO-BEDROOM RENTAL HOUSING WAGES

Represents the hourly wage that a full-time worker must earn (working 40 hours a week, 52 weeks a year) in order to afford the Fair Market Rent for a TWO-BEDROOM RENTAL HOME, without paying more than 30% of income.




Figure 2: Forecasted Relative Change in the 65 and Older Homeless Population Compared to 2017

### HOME SAFE PROGRAM OVERVIEW

Goal is to prevent homelessness among adult protective services clients referred due to abuse, neglect or financial exploitation

Established by SB 1811 (Chapter 35, Statutes of 2018)

\$15 million available over 3 years

Dollar-for-dollar match


\$30 million in funding requests





## HOME SAFE PROGRAM OVERVIEW


- Services to be offered include rental arrearages, short term rental assistance, utility payments, deep cleaning, legal services and eviction prevention, landlord mediation, and intensive case management.
- Importance of partnerships with local homeless Continuum of Care as well as community housing and service providers





#### DATA & PROGRAM EVALUATION REQUIREMENTS

- The Statute requires that awardees submit specific data elements, including any future incidents of APS referrals or homelessness.
- Awardees must also participate in a program evaluation, to be conducted by a third party research entity.


### Continuum of Care (CoC)

- Per WIC Section 15771, individuals that require supportive housing shall be referred to the local homelessness CoC for longterm services that promote housing stability.
- Each Home Safe funded county has been working with their respective CoC, as they continue to develop their Home Safe program & establish program policies.
- Counties are also encouraged to partner with other regional efforts to create and participate in the homeless Coordinated Entry System.
