- Sessions with only one proposed speaker are discouraged.
- Presenters who are county human services staff who would have otherwise attended the CWDA Conference will be expected to pay the full registration fee as well as travel costs if they are selected to present. CWDA covers travel cost of non-county speakers and allows those non-county speakers to attend sessions on the day of their presentation only, but encourages non-county speakers to attend the entire conference at a reduced rate.
- Sponsors/vendors are prohibited from submitting proposals and from being on presentation panels.
