This results in severe trauma to the victim that requires intensive services to protect the victim from their perpetrators and help them in their long journey to recovery. Effectively serving the CSEC population requires that services are delivered through a targeted and multi-disciplinary approach.

In our County, we have been working collaboratively with other systems including law enforcement, our Juvenile Courts, probation, education, mental health, public health, local non-profits, and others to leverage resources to serve this population. In 2015, our Child Welfare agency worked collaboratively with these partners to develop the Contra Costa County Interagency Protocol for Serving CSEC. This Protocol outlines the ways in which Contra Costa County will partner to address the complex needs of children exploited in our community as well as within our foster care system. Additionally, we have worked steadily to identify CSEC youth as well as at-risk youth within our community, foster care and probation systems.

New federal and state mandates require child welfare agencies to develop and implement local protocols to identify foster youth who are victims of CSEC and link these youth to appropriate services. While our county has taken steps to begin to serve CSEC victims through the development of local interagency response protocols, additional resources are needed to

implement our protocols and effectively serve youth. These include ensuring consistent messaging and consistent training for the community and our systems for CSEC identification, mechanisms for accurate screening for exploitation, broader and culturally specific service provision, enhanced and safe housing and placement resources, as well as funding for staff and service providers to outreach and serve our most vulnerable children. Once identified, victims require crisis stabilization and often have physical health needs that require immediate attention. They need safe housing with enhanced supervision and support to protect them from their perpetrator. Their perpetrators controlled everything and their victims often were left with nothing of their own, requiring emergency clothing, toiletries, and basic living supplies. Some victims will be saved with their own young children who also need support and services. These complex cases also require multi-disciplinary teams to meet frequently and quickly to leverage resources and coordinate services, and specially-trained social work staff in the child welfare agency to facilitate this process.

We greatly appreciate the Legislature's and Administration's investment of \$14 million in the 2015-16 budget year to begin to build capacity in local child welfare systems. Contra Costa County urges your support for an increase of \$19.7 million to enable our county to more effectively serve CSEC victims.


